Introduction

This health and safety policy sets out our general approach to health and safety. It explains how we, will manage health and safety in at our sessions of tuition to keep our freelance teachers, tutor and students safe and healthy.

We are aware that this type of Health and Safety policy may not be required for our association in writing, as we have less than five employees. However, we want to ensure our association has this written documented to assist the board of the school, teachers/tutiors and parents understand the policy.

We will share the policy, and any changes to it, with our employees.

Part 1: Statement of intent

This is the Health and Safety policy statement of Swedish School Association in Scotland / Svenska Skolföreningen i Skottland.

Our health and safety policy is to:

- Prevent accidents and keep our students and teachers/tutors safe
- Manage health and safety risks during our tuition
- Provide clear instruction and information, and as needed adequate training, to ensure the teachers/tutor are able to follow the health and safety policy
- consult with teachers/tutors on matters affecting their health and safety
- consult with parents, as required, on matters affecting their child's health and safety
- maintain safe and healthy working conditions
- implement emergency procedures, including evacuation in case of fire and other significant incidents
- review and revise this policy as required on an annual basis around the timeframe of the AGM of Swedish School Association in Scotland (Svenska Skolföreningen i Skottland).

We will give teachers/tutors health and safety induction by sharing all necessary
policies and procedures. This will also be shared with any new teacher/tutors and
board members of the Swedish School Association Scotland.

3.4 Safeguarding policy to guard against abuse of children

- We will ensure we follow our Safeguarding Policy and review and update this as necessary on an annual basis.
- Part of this is to ensure we do criminal record checks on all our teachers/tutors (Basic DBS).

3.5 Fire safety Procedure

- We will ensure we follow the fire safety procedure of the location where we hold the tuition.
- We will ensure the procedure is updated as necessary, for example when the location of tuition is relocated.

3.6 Evacuation

- We will make sure escape routes are signed and kept clear at all times.
- Evacuation plans are tested annually and updated as necessary.

3.7 Report and Evaluate

- The teachers/tutors will report any substantial injuries taken place during tuition in writing to the board of the Swedish School Association within the same working day.
- This will assist the evaluation of policies or procedures which may require updates due to the injury.
